Update to Clinical Practice Guidelines and Preventive Health Care Guidelines

The *Clinical Practice Guidelines* and *Preventive Health Care Guidelines* have been updated. They are both available on the Anthem Blue Cross provider website at: https://mediproviders.anthem.com/ca/pages/quality-improvement-program.aspx.

These evidence-based guidelines were reviewed and approved by our Quality committees. The guidelines include direct links to the source documents for reference.

Updates include:

- Preventive Health guidelines: Addition of Risk Assessments / Screening
 - Birth to 24 months
 - Blood Pressure: at each visit
 - Lead Exposure: as appropriate
 - Lipid Disorder: at 24 months
 - Tuberculosis: screening based on risk factors
 - Child ages 2 ½ to 10 years
 - Lead Exposure: through age 6
 - Hemoglobin or hematocrit (blood count): every year
 - Blood pressure: risk assessments prior to age 3
 - Lipid Disorder: Risk Assessments when testing not performed
 - Tuberculosis: screening based on risk factors
 - Child/Adolescent ages 11 to 20 years
 - Hemoglobin or hematocrit (blood count): Every year
 - Tobacco, Alcohol or Drug Use: Each year beginning at age 11
 - Additional Changes
 - Introductory paragraphs for each non-adult age group revised to reflect language in the AAP Bright Futures guidance
 - Footnotes regarding immunizations: Hepatitis A (ages 2 to 18), Tdap (ages 7 to adult) and HPV (ages 27 to 45) revised to reflect the Advisory Committee on Immunization Practices (ACIP) language
