## Behavioral health outpatient authorization process

Effective immediately, authorization requirements for the services below have been removed. Providers are still required to submit the *Behavioral Health Treatment Data Sharing Form* or a copy of the primary medical provider notification letter within five business days of the initial diagnostic interview. Codes 96150 to 96155, when filed for applied behavior analysis therapy (with modifiers), require authorization.
