Updates to AIM Specialty Health musculoskeletal interventional pain management clinical appropriateness guideline

This communication applies to the Medicaid and Medicare Advantage programs for Anthem Blue Cross and Blue Shield (Anthem).

Effective for dates of service on and after March 13, 2022, the following updates will apply to the clinical appropriateness guideline for musculoskeletal (MSK) interventional pain management from AIM Specialty Health_®.* As part of the AIM guideline annual review process, these updates are focused on advancing efforts to drive clinically appropriate, safe, and affordable healthcare services.

Updates by section:

- Epidural injection procedures (ESI) and diagnostic selective nerve root blocks (SNRB):
 - o Allow more frequent ESI in newly diagnosed patients
 - o Remove imaging requirement in certain circumstances
 - o Require similar criteria as ESI for diagnostic SNRB
 - o Add epidural abscess as a contraindication
 - Limit multilevel and combination diagnostic SNRB
- Paravertebral facet injection/medial branch block (MBB)/neurolysis:
 - o Limit indefinite use of diagnostic MBB
 - o Add indication for diagnostic pars defect MBB
 - o Expand exceptions allowed for intraarticular facet injections
 - o Define MBB timing with respect to radiofrequency neurotomy, MBB limited to RFA candidacy
 - o Limit open surgical neurolysis and limited multiple spinal injections
- Sacroiliac joint injections:
 - o Limit indefinite use of diagnostic intraarticular injections
 - Disallow sacral lateral branch blocks
 - o Disallow sacroiliac joint therapeutic injections in a previously fused joint
- Spinal cord and nerve root stimulators:
 - o Allow minimally invasive pain procedures to satisfy conservative management definition
 - o Specify timing of mental health evaluation
 - Define indications for repeat stimulator trial
