

Project BRAVO — Behavioral health enhancements

Please note, this communication applies to Anthem HealthKeepers Plus, Medallion and Anthem HealthKeepers Plus, Commonwealth Coordinated Care Plus (Anthem CCC Plus) offered by HealthKeepers, Inc.

Effective July 1, 2021, the Anthem HealthKeepers Plus and Anthem CCC Plus plans will implement coverage of the following high-quality, high-intensity, and evidence-based behavioral health services:

- Assertive community treatment (ACT)
- Mental health partial hospitalization program (MH-PHP)
- Mental health intensive outpatient program (MH-IOP)

Some of these services are available today; however, there are several enhancements to existing services along with new services becoming available. We provide these services to shift focus to prevention and early intervention for behavioral health disorders and to support alignment of services across systems that serve our members.
